

Marshallville Village Council  
Regular Meeting at Municipal Building  
7:00 p.m.  
April 2, 2007

Mayor Brooker called the meeting to order. Council members present were David Orr, Rich Stoll, Sue Neal, Heather Lessiter and Martha Ann Martin. Councilman Dan Lepley was not present.

It was moved by Mr. Stoll and seconded by Mrs. Neal to approve the minutes of the March 5, 2007 regular Council meeting. The motion was approved unanimously with the following correction: the date of the April meeting should be April 2 and not April 4.

It was moved by Mr. Stoll and seconded by Ms. Lessiter to accept the March, 2007, financial report. The motion was approved unanimously.

It was moved by Mr. Stoll and seconded by Ms. Lessiter to accept the February, 2007, financial report. The motion was approved unanimously.

Chief Bob Peters gave the fire report for March 2007. Chief Peters reported that firefighters will need 18 hours of continuing education each year for certification.

Mayor Brooker reviewed a memorandum from County Auditor Jarra Underwood regarding five levy options. It was moved by Mr. Stoll and seconded by Mrs. Neal to begin the process of placing a 2.5 mill replacement levy with increase on the ballot. The motion was approved unanimously.

It was moved by Ms. Martin and seconded by Mr. Stoll to approve the following rates for mowing violations including time to and from a municipally designated facility: \$100 for the first hour and \$75 for each additional hour. The motion was approved unanimously.

It was moved by Mr. Orr and seconded by Mr. Stoll to renew the contract with G&O spraying at a cost of \$315 per spraying and \$480 for the larvaciding program. The motion was approved unanimously.

It was moved by Mr. Stoll and seconded by Ms. Lessiter to accept the proposal from Weeman Construction to repair the sidewalk on Chestnut Street at a cost of \$2,450. The motion was approved unanimously.

Mayor Brooker presented Ordinance 07-06 to rename Euclid Street extension to Bristol Lane for its first reading.

Mayor Brooker presented Ordinance 07-07 for designated parking on Euclid Avenue for its first reading.

It was moved by Mr. Stoll and seconded by Mr. Orr to adopt Claims Ordinance 07-08. The motion was approved unanimously.

It was moved by Mr. Stoll and seconded by Mr. Orr to adopt Claims Ordinance 07-09. The motion was approved unanimously.

Mayor Brooker presented the Mayor's Court report for March, 2007.

Mayor Brooker announced that the tornado siren will be tested the first Wednesday of every month at 12:10 p.m.
