Chief Bob Peters gave the fire report for August, 2007.

It was moved by Mr. Orr and seconded by Ms. Martin to move Police Officer Michael Murphy from paid part-time to auxiliary status. The motion was approved unanimously.

Mayor Brooker presented Ordinance 07-21 prohibiting certain vehicles from parking in the Village lot at 7 N. Main Street, for its second reading.

Mayor Brooker presented Ordinance 07-22 regulating the placement and retrieval of trash receptacles in the Village for its second reading.
